Introduction:

This Admissions Policy outlines the criteria and procedures for admitting children to Park Road Academy Nursery. It ensures fairness, transparency, and compliance with relevant laws and regulations. Park Road Academy Nursery is committed to providing equal access and opportunities to all applicants, regardless of race, religion, gender, or disability.

Admission Criteria:

Age Eligibility: Children must be aged 3 years on or before 31st August to be considered for enrolment in Park Road Academy Nursery for the September 2026-2027 academic year.

Priority Categories:

- 1) 'Looked after' children including previously looked after children. A looked after child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in section 22 (1) of the Children Act 1989). A previously looked after child is a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangement orders or special guardianship order.
- 2) Those children who live in the catchment area of Park Road Academy Primary School who will have a sibling attending Park Road Academy Primary School at the time of the applicant's proposed admission (including half/step/adopted/foster brothers or sisters, and any other children who are living at the same address as part of the same family unit).
- 3) Children who live outside the catchment area of Park Road Academy Primary School, with a sibling attending Park Road Academy Primary School at the time of the applicant's proposed admission (including half/step/adopted/foster brothers or sisters, and any other children, who are living at the same address as part of the same family unit).
- 4) Those children who live in the catchment area of Park Road Academy Primary school.
- 5) Children of staff members where the member of staff has been employed at the school for 2 or more years at the time at which the application for admission to the school is made and will be employed at the school at the time of the applicant's proposed admission.
- 6) Children who live nearest to the School, calculated in a direct straight line from the child's permanent place of residence to the school.



Application Process:

1. Parents/Carers interested in securing a place for their child at Park Road Academy Nursery must complete the registration form via the "Apply" option at the top of the school website.
2. Applications must be submitted by the specified deadline mentioned on the Nursery's official website or communicated through other appropriate channels.

Offer of Places:

1. Offers of places will be sent to Parents/Carers based on the priority categories and available spaces.
2. Parents/Carers who are offered a place will receive written communication via email from the Nursery. This communication will specify the deadline for confirming acceptance.

January Intake for 2025:

If places are available in September, we will make contact with those parents with children on the waiting list who turn 3 from September to December before the January intake.

Acceptance and Enrolment:

1. To secure the offered place, Parents/Carers must submit the required enrolment forms, non-refundable payment of £40.00 to secure the place, by the specified deadline.
2. Failure to submit the necessary documents and fee by the deadline may result in the withdrawal of the offered place.

Appeals Process:

Parents/guardians who are dissatisfied with the outcome of their application may appeal in writing to the Headteacher of Park Road Academy Nursery. Appeals will be reviewed in accordance with the school's appeals process and relevant legal regulations.

Review of the Admissions Policy:

This Admissions Policy is subject to periodic review and may be updated to reflect changes in local authority regulations, school capacity, and other relevant factors.
